APPEARANCE RELEASE

“THE MARIACHI MIRACLE”

The rights granted herein shall also include the right to edit, delete, dub and fictionalize the Footage, Materials and the Film as Producer sees fit in Producer’s sole discretion.

I hereby acknowledge and agree that Producer has no obligation to me whatsoever. Without in any way limiting the foregoing, I acknowledge and agree that Producer is under no obligation to select me to participate in the Film or to include Footage and Materials in the Film.

I represent and warrant the following I am at least 18 years of age and have the full, complete and unrestricted right and authority to enter into this agreement but if I am not at least 18 years of age, I agree to have my parent or legal guardian sign the acknowledgement at the end of this release.

I hereby waive any rights, claims or interest I may have to control the use of my identity or likeness in whatever media used for the above purpose and in no event shall I seek to enjoin or otherwise delay the development, production, distribution, exhibition, promotion, or other exploitation of the Film.
